- The restricted stock unit award includes a total of 38,551 shares. 3,855 shares of the restricted stock unit award will vest on January 30, 2010; an additional 7,710 shares will vest on January 30, 2011; an additional 11,565 shares will vest on January 30, 2012; and the remaining 15,421 shares will vest on January 30, 2013.
- The restricted stock units were granted under an incentive compensation plan maintained by M&T Bank Corporation, and therefore the reporting person paid no price for the restricted stock units.
